The **CITY OF GALLATIN** will be soliciting bids for **Contract 524 – Sumner County Regional Transmission Main – Line A**. Separate sealed bids for **Contract 524 – Sumner County Regional Transmission Main – Line A** will be received by the **CITY OF GALLATIN** at **239 Hancock Street, Gallatin, TN 37066**, until **10:00 A.M., local time, on December 12, 2024**, and then at said office publicly opened and read aloud. Any person with a disability requiring special accommodation must contact the **CITY OF GALLATIN** no later than 7 days prior to the bid opening.

CONTRACT 524 - consists of furnish & install approximately 38,800 L.F. of 20” ductile iron water line, valves, fittings, fire hydrants, air release valves, pavement replacement, and related appurtenances as shown on the plans.

SPECIAL NOTICE TO DISADVANTAGED BUSINESS ENTERPRISES (DBE) FIRMS

All qualified Disadvantaged Business Enterprises (DBE) firms desiring to bid as a General Contractor, sub-contractor, professional service provider, supplier, or equipment vendor are encouraged to contact the Governor's Office of Diversity Business Enterprise office listed above to review bidding/contract documents. Qualified Disadvantaged Business Enterprises (DBE) firms may also contact James C. A detailed listing of all subcontractors shall be provided by the Bidder. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must also not appear on Sam.gov disbarment list. Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of the **CITY OF GALLATIN**.

No bid may be withdrawn within 90 days after the scheduled time for receipt of bids thereof.
The owner reserves the right to waive any informalities or to reject any or all bids.
