The EAST MONTGOMERY UTILITY DISTRICT will be soliciting bids for **Contract 124 – Highway 12 Water Line Replacement – Phase 1**. Separate sealed bids for **Contract 124 – Highway 12 Water Line Replacement – Phase 1** will be received by the EAST MONTGOMERY UTILITY DISTRICT at **5195 Highway 41A South, Clarksville, TN 37043**, until **10:00 A.M., local time, on March 6, 2025**, and then at said office publicly opened and read aloud. Any person with a disability requiring special accommodation must contact the EAST MONTGOMERY UTILITY DISTRICT no later than 7 days prior to the bid opening.

**CONTRACT 124** consists of the installation of approximately 18,800 linear feet of 8" and 6" PVC water main, 1 control valve installation and all necessary appurtenances to provide a complete line installation per the plans and specifications. This project is being supported with Treasury, Coronavirus State and Local Recovery Fund grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity.

The allotted time for construction is 300 calendar days.

In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted.

Subcontractors must also not appear on Sam.gov disbarment list. Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of the **EAST MONTGOMERY UTILITY DISTRICT**.

No bid may be withdrawn within 90 days after the scheduled time for receipt of bids thereof.

The owner reserves the right to waive any informalities or to reject any or all bids.
