Separate sealed bids for **Contract 125 – Force Main Relocation** will be received by the **TOWN OF KIMBALL - 675 Main Street, Kimball, TN 37347**, until **2:00 P.M., local time, on April 29, 2025**, and then at said office publicly opened and read aloud. Any person with a disability requiring special accommodation must contact the **TOWN OF KIMBALL**. no later than 7 days prior to the bid opening.

CONTRACT 125 – Force Main Relocation consists of the installation of approximately 2,600 linear feet of 8" PVC force main, including a 500' HDPE directional bore including all necessary appurtenances to provide a complete line installation per the plans and specifications. This project is being supported with Treasury, Coronavirus State and Local Recovery Fund grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity.

The allotted time for construction is 270 calendar days.

The Copeland "Anti-Kickback" Act is also applicable, which prohibits workers on construction contracts from giving up wages that they are owed. Contractors must not appear on Sam.gov disbarment list. A detailed listing of all subcontractors shall be provided by the Bidder. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must also not appear on Sam.gov disbarment list.

Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of the **TOWN OF KIMBALL**.

No bid may be withdrawn within 90 days after the scheduled time for receipt of bids thereof.

The owner reserves the right to waive any informalities or to reject any or all bids.
