#### WATER TREATMENT PLANT ROOF REPLACEMENT

#### SCOPE OF WORK

The Town of Monterey is requesting sealed bids for providing the replacement of a roof on its Water Treatment Plant.

#### **Description of Work:**

The roof replacement consists of approximately 2,500 square feet of membrane roof. The proposed slope shall match existing as close as possible. Membrane roof shall meet the specifications provided in this package. The existing roof shall be completely removed and disposed of by the CONTRACTOR. Existing trim, flashing, and 2x10 nailer shall be removed and replaced following completion of roof.

Upon request, bidders shall provide a brief Statement of Qualifications including the number of years of experience with this type of work and a list of references, and a schedule for performing the work.

As a minimum, qualifications of contractor shall include one of the following:

- 1. Five (5) years of experience in the commercial/ industrial/ municipal roofing industry.
- 2. Completed a minimum of three (3) commercial/ industrial/ municipal roofing installation (or replacement) projects valued at \$50,000 or more each, in the last three (3) years.

The cleaning, removal, and transportation of construction debris shall be the responsibility of the contractor. Contractor shall conform to all TDEC rules associated with air quality, solid waste disposal, etc... Contractor shall conform to all OSHA rules regarding the type of work performed. Additionally, Contractor shall ensure that all work and conduct at the site be in accordance with all local, state, and federal laws.

Furnish a Certificate of Insurance to the Owner naming the Town of Monterey as certificate holder, including Workman's Compensation with employer's liability, commercial general liability, umbrella liability, and vehicle liability. Both the Town of Monterey and James C. Hailey & Company shall be listed as "additional insured".

No company may withdraw their bid within 90 days after the deadline for submittal.

### ROOFING SPECIFICATIONS

- 1. Description of proposed roof on control and filter building:
  - a. Tapered Expanded Polystyrene Roof Insulation with 2" minimum thickness and 8" maximum thickness. Installation is to be in accordance with Carlisle's (or approved equal) recommendations and requirements.
  - b. Over roof insulation, install Carlisle Design B Roof System (or approved equal) complete with flashing and accessories as required. This is a .060 EPDM loose laid and ballasted roof system weighing approximately 13 lb. per square foot. Manufacturer's 10-year warranty is to be furnished upon completion, inspection, and acceptance by manufacturer.
  - c. Perimeter sheet metal work is to be fabricated from .032 mill finish aluminum to profiles as shown [and to match existing] with dimensions as dictated by field measurement. Please remove and replace 2" x 10" nailer(s) around perimeter.
