Separate sealed bids for **CONTRACT 125 – WATER PUMP STATION** will be received by the **CAGLE-FREDONIA UTILITY DISTRICT, 7499 State Route 399, Dunlap, TN 37327**, until **2:00 P.M., local time, on July 24, 2025**, and then at said office publicly opened and read aloud. CONTRACT 125 consists of construction of a 100 gpm package water booster pump station on John Henry Lewis Road, an all necessary appurtenances as per the plans and specifications. A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of the **CAGLE-FREDONIA UTILITY DISTRICT**.

No bid may be withdrawn within 90 days after the scheduled time for receipt of bids thereof.
