The WEST CUMBERLAND UTILITY DISTRICT will be soliciting bids for **Contract 224 – ARPA Water System Improvements**. Separate sealed bids for **ARPA Water System Improvements** will be received by the **WEST CUMBERLAND UTILITY DISTRICT** at **321 East Main Street, Pleasant Hill, TN 38578**, until **11:00 A.M., local time, on July 29, 2025**, and then at said office publicly opened and read aloud. Any person with a disability requiring special accommodation must contact the **WEST CUMBERLAND UTILITY DISTRICT** no later than 7 days prior to the bid opening.

**CONTRACT 224** consists of the replacement of approximately 7,500 Linear feet of 6", 4" and 2" water mains with 6", 4" and 2" PVC water line along Elm St., Hickory Hill Rd., Yonside Dr., Maple Cir., Oak Ln., Mayland Rd., and Hwy 70, including all labor, materials, testing and disinfection and all necessary appurtenances to provide a complete line installations per the plans and specifications. The allotted time for construction is 270 calendar days.
